I. There is no obligation for the client to rent a safe deposit box in either of the choices stated. The client registers for a future rental of an accessible and eligible safe deposit box. The registration fee does not include the future rent and the rent shall be paid directly to the bank or gold bullion deposit. BEACCONSULT never retains access to the client's vault.

II. The BEACCONSULT company can never be coerced to rent out a safe deposit box if the requirements by BEACCONSULT or the banks can not be fulfilled due to governmental restrictions or by law or if the client is not eligible to rent a safe deposit box, due to passport or visa requirements or restrictions by law in such countries as requested. In this case, the client will be offered alternative choices. The client is not obligated to pay any fee or rent to BEACCONSULT or its affiliated banks or safe deposit box providers at any time and the client may rent a safe deposit box at the time of his/her choosing. BEACCONSULT can never force the contractors or the client to rent a safe deposit box.

The registration fee will only be reimbursed fully, if BEACCONSULT can not offer any alternatives at any future time during this agreement and can not serve the customer at all.

IV. The registration can be withdrawn or cancelled by e-mail: [kontakt@beaconsult.de](mailto:kontakt@beaconsult.de) or by mail within 14 days after the confirmation. After 14 days the contract can not be withdrawn. The fee is due immediately after submitting this form.

V. The registration lasts 12 months from the day of its confirmation and will be extended for another 12 months, if the client does not cancel the registration 4 weeks before the expiry date as stated in the confirmation.

#### VI. Severability Clause

If a provision of this agreement is or becomes legally invalid or if there is any gap that needs to be filled, the validity of the remainder of the agreement shall not be affected thereby. Invalid provisions shall be replaced by common consent with such provisions which come as close as possible to the intended result of the invalid provision. In the event of gaps such provision shall come into force by common consent which comes as close as possible to the intended result of the agreement, should the matter have been considered in advance. Any changes of or amendments to this agreement must be in writing to become effective. If performance by either party is prevented, restricted or delayed due to any cause arising from events, non-happenings, omissions, accidents or acts beyond the reasonable control of the party due to perform or when attributable to acts of higher force, compliance in good faith with any applicable foreign or domestic governmental regulation or order, whether or not it proves to be invalid, no party shall have any liability to any other party for delay or non-delivery in the performance of its obligations under this agreement. Abode of liability, residence and court is Hamburg – Germany.
