BEACCONSULT never retains access to the client's vault. The fee can not be reimbursed if the client rejects the offers of the safety deposit box providers.

II. The BEACCONSULT company can never be coerced to provide or offer a safety deposit box if the requirements by BEACCONSULT or the banks can not be fulfilled due to governmental restrictions or by law or if the client is not eligible to rent a safety deposit box, due to passport or visa requirements or restrictions in such countries as requested. In this case, the client will be offered alternative choices. The client is not obligated to pay any rent to BEACCONSULT or its affiliated banks or safety deposit box providers in advance and the client may rent a suggested safety deposit box at the time of his/her choosing. The registration and the fee is valid for one country of the client's choice and has no continuing obligation. All future external expenses, such as lawyers and notary fees, banking fees are not included and all external costs are in the responsibility of the client to pay. The BEACCONSULT can and does not offer or apply entry visa to any country.

III. BEACCONSULT can never force a safety deposit box provider or a bank nor the client to rent a safety deposit box. The registration fee will only be reimbursed fully, if BEACCONSULT can not offer any alternatives at any future time or can not serve the customer at all.

VI. Severability Clause

If a provision of this agreement is or becomes legally invalid or impossible to fulfill due to any cause arising from events, non-happenings, omissions, accidents or acts beyond the reasonable control of the party due to perform or when attributable to acts of higher force or if there is any gap that needs to be filled, the validity of the remainder of the agreement shall not be affected thereby. Invalid provisions shall be replaced by common consent with such provisions which come as close as possible to the intended result of the invalid provision. Any changes of or amendments to this agreement must be in writing to become effective. Abode of liability, residence and court is Hamburg – Germany.
